

CSLS Competition Regulations 2018

1. Applicability of the Regulations

- 1.1 These Regulations apply to all Curtin Student Law Society ('CSLS') competitions, except where it is identified that a regulation or regulations apply to a specific competition or competitions.
- 1.2 By entering into any of the CSLS competitions in 2018, the competitors acknowledge that they have read and understood all the Regulations and relevant Competition Rules and agree to be bound by them without limitation or equivocation. In addition, competitors agree that if they engage in behaviour constituting a breach of any of these rules they will be subject to the penalties contained in these Regulations.
- 1.3 The 2018 Competitions Director is Lewis Pope. The Competitions Director is the final arbiter of any disputes arising in the course of any CSLS competitions and may exercise her or his discretion when resolving disputes or modifying these Regulations, or any relevant Competition Rules, to ensure the efficient operation of the CSLS competitions in 2018.

2. Eligibility to Compete

- 2.1 Any student wishing to compete in a CSLS competition must be a current member of the CSLS. Possession of a Curtin University Student Identification Card is not sufficient to allow entry into CSLS competitions.
- **2.2** Competitors in junior competitions must have completed 8 law units or less.
- 2.3 Any student wishing to compete in a CSLS competition must register to participate in the relevant by the date and time nominated, utilising the method nominated. The acceptance or refusal of late entries is at the discretion of the Competitions Director who, in making her or his decision, will consider the surrounding circumstances of the late submission.

3. Late Withdrawal From Competitions

- **3.1** Prior to entering a competition, competitors should ensure they are able to commit for entire duration of the competition.
- 3.2 Any competitor who withdraws from a competition within 4 days of its commencement may be noted and prevented from competing in competitions for the remainder of the year.

3.3 The Competitions Director has the discretion to retract any decision made under regulation 3.2 and to allow any competitor to compete in remaining competitions.

4. Spectators

- **4.1** Teams are prohibited from watching other teams compete while they remain in the competition, unless expressly allowed by the relevant Competition Rules.
- **4.2** Spectators are welcome to attend and watch competitions.
 - **4.2.1** The Competitions Director, or Judges, may deny entry to, or remove from, spectators that exhibit unruly or disruptive behaviour at any point during a competition, or prior competitions.

5. Draws

5.1 Competitors must accurately state their availability during sign-up prior to the commencement of each competition.

6. Arrival Times

- 6.1 Competitors must arrive at the scheduled venue for their round 10 minutes prior to the commencement of that round.
 - **6.1.1** Competitors will be given a 10 minute grace period to arrive after the scheduled commencement of the round.
- Where a team fails to present itself for a round of competition at the designated time, they will be deemed to have forfeited that round and are eliminated from the relevant competition.

9. Appeals

- **9.1** Any complaints regarding a CSLS competition can be forwarded to the Competition Director within 24 hours of the end of any round.
- **9.2** The decision of the Competitions Director will be made within 24 hours of the receipt of an appeal. The Competitions Director's decision is final.

10. Competitions Attire

10.1 All competitors must be dressed in formal business attire for competitions. Any competitor who fails to comply with this requirement will not be permitted to compete.
